

Information on the Processing of Your Personal Data

We would like to inform you about the processing of your personal data in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as the “Regulation”).

1. Who is the controller of your data?

3. What personal data do we process about you and why?

I. Your personal data such as your name, surname, and e-mail address are processed for the purpose of your registration for the event organized by us, so that we know who will attend our event and what number of participants to expect. It is also necessary to process your personal data so that we can inform you in time about a change of date, cancellation of the event, or full capacity and your placement on a waiting list. This processing of your personal data is carried out on the legal basis of the performance of a contract and our legitimate interest under Article 6(1)(b) and (f) of the Regulation. Our

legitimate interest in this case is to ensure sufficient venue capacity, to protect our property, and to ensure the safety of all persons at the event location. We will process this personal data only for the duration of the Conference Science Communication 360°. If you do not provide this data, we will not be able to notify you in time of all organizational changes or of full capacity.

This processing of personal data based on our legitimate interest does not require your consent, but you have the right to object to such processing at any time free of charge.

II. Your personal data such as photographs, image and audio recordings relating to you will be processed for journalistic and reporting purposes, so that we can provide public information about the event on our websites www.komunikacevedy360.cz, www.avcr.cz, www.fsv.cuni.cz and www.scicomhub.cz, as well as on social networks such as Facebook, Instagram and YouTube, or in newsletters. This processing of your personal data for journalistic and reporting purposes is carried out on the legal basis of our legitimate interest under Article 6(1)(f) of the Regulation. The legitimate interest in this case is providing information to the public about the activities of the Academy of Sciences of the Czech Republic and the Faculty of Social Sciences of Charles University in a news-reporting manner and providing information to the public for the purpose of promoting science. This personal data will be processed only for the period strictly necessary to fulfil the stated purpose, but no longer than one year.

Providing this data is voluntary. If you express disagreement at the moment of their collection with the taking of photographs or image or audio recordings relating to your person, your disagreement will be respected and the photographs or recordings will not be taken.

If you do not provide this data, we will not be able to provide information to the public about our activities using your photographs or image and audio recordings.

This processing of personal data based on our legitimate interest does not require your consent, but you have the right to object to such processing at any time free of charge.

4. Who are the recipients of your personal data?

We transfer your personal data only to the necessary extent to the following categories of recipients:

- authorised employees of the controller;
- our contractual partners, if they participate alongside us in the processing of your personal data (i.e., processors), such as those providing technical support, service or operation of our computer systems, programs, networks, and websites, or providers of data storage services;

- the public, in the case of publication of photographs or image or audio recordings on our websites www.komunikacevedy360.cz, www.avcr.cz, www.fsv.cuni.cz and www.scicomhub.cz and on social networks such as Facebook, Instagram and YouTube.

5. What are your rights?

You have the right to:

- Request confirmation from the controller as to whether your personal data are being processed, and if so, the right to access such data;
- Rectification of outdated or incomplete data;
- Erasure of personal data relating to you or restriction of their processing.

Furthermore, you have the right to:

- Data portability.
